## Frith-Bhulaíochta – *Anti-Bullying Policy*

1. I gcomhréir le riachtanais an Acht Oideachais (Leas) 2000 agus na dtreoirínte faoi chód iompair a d'eisigh an Bord Náisiúnta um Leas Oideachais tá an beartas frithbhulaíochta seo a leanas glactha ag Bord Bainistíochta GaelscoilUí Riada mar chuid de chód iompair iomlán na scoile. Géilleann an beartas go huile agus go hiomlán do riachtanais *Ghnásanna Frithbhulaíochta Bunscoile agus Iar-bhunscoile* a foilsíodh i Meán Fómhair 2013. In accordance with the requirements of the Education (Welfare) Act 2000 and the code of behaviour guidelines issued by the NEWB, the Board of Management of Gaelscoil Uí Riada school has adopted the following anti-bullying policy within the framework of the school's overall code of behaviour. This policy fully complies with the requirements of the *Anti-Bullying Procedures for Primary and Post-Primary Schools* which were published in September 2013.

2. Aithníonn an Bord Bainistíochta a thromchúisí atá iompar bulaíochta agus a dhiúltaí a d'fhéadfadh a thionchar a bheith ar dhaltaí, agus geallann an scoil dá réir cloí leis na príomhphrionsabail dea-chleachtais seo a leanas agus iompar bulaíochta á chos agus á chomhrac.

- Feidhmiú straitéisí oideachais agus coiscthe (lena n-áirítear bearta chun feasacht a mhúscailt)
  - a chothaíonn ionbhá, meas agus athléimneacht sna daltaí; agus
  - ina dtéitear i ngleic go sainráite le cibearbhulaíocht agus le bulaíocht bunaithe ar aitheantas, lena n-áirítear bulaíocht homafóbach agus trasfóbach;
- Maoirseacht agus monatóireacht éifeachtach ar dhaltaí;

  - is welcoming of difference and diversity and is based on inclusivity;
  - encourages pupils to disclose and discuss incidents of bullying behaviour in a non-threatening environment; and
  - promotes respectful relationships across the school community;
- Effective leadership;
- A school-wide approach;
- A shared understanding of what bullying is and its impact;
- Implementation of education and prevention strategies (including awareness raising measures) that-
  - build empathy, respect and resilience in pupils; and
  - explicitly address the issues of cyber-bullying and identity-based bullying including in particular, homophobic and transphobic bullying.
- Effective supervision and monitoring of pupils;
- Supports for staff;
- Consistent recording, investigation and follow up of bullying behaviour (including use of established intervention strategies); and
- On-going evaluation of the effectiveness of the anti-bullying policy.

Ní chuimsíonn an sainmhíniú seo ar bhulaíocht teagmhais aonraithe nó teagmhais aon uaire d'iompar diúltach d'aon turas, lena n-áirítear téacsteachtairacht mhaslach nó goilliúnach aon uaire nó teachtaireachtaí príobháideacha eile agus ba cheart déileáil leo, mar is cuí, de réir chód iompair na scoile.

**In accordance with the *Anti-Bullying Procedures for Primary and Post-Primary Schools* bullying is defined as follows:**

Bullying is unwanted negative behaviour, verbal, psychological or physical conducted, by an individual or group against another person (or persons) and which is repeated over time.

The following types of bullying behaviour are included in the definition of bullying:

- deliberate exclusion, malicious gossip and other forms of relational bullying,
- cyber-bullying and
- identity-based bullying such as homophobic bullying, racist bullying, bullying based on a person's membership of the Traveller community and bullying of those with disabilities or special educational needs.

Isolated or once-off incidents of intentional negative behaviour, including a once-off offensive or hurtful text message or other private messaging, do not fall within the definition of bullying and should be dealt with, as appropriate, in accordance with the school's code of behaviour.

However, in the context of this policy, placing a once-off offensive or hurtful public message, image or statement on a social network site or other public forum where that message, image or statement can be viewed and/or repeated by other people will be regarded as bullying behaviour.

Negative behaviour that does not meet this definition of bullying will be dealt with in accordance with the school's code of behaviour.

Additional information on different types of bullying is set out in Section 2 of the *Anti-Bullying Procedures for Primary and Post-Primary Schools*.

- Tabhairt go comhsheasmhach fé theanga dhiúltach , homafóibe agus trasfhóibe, nó riachtanais foghlama is speisialta san áireamh/consistently tackle the use of discriminatory and derogatory language in the school – this includes homophobic and racist language and language that is belittling of pupils with a disability or SEN.

- Múineadh soiléir faoi úsáid cheart na meán sóisialta/Explicitly teach pupils about the appropriate use of social media.
  - Spreagadh dearfach a thabhairt do dhaltaí chun chloí le rialacha maidir le fóin póca is PUI/Positively encourage pupils to comply with the school rules on mobile phone and internet use.
  - Críoch ceart a chur le hiniúchadh briseadh na rialacha scoile/Follow up and follow through with pupils who ignore the rules.

Any parent concerned about possible instances of bullying should speak first to the class teacher.

❖ ‘Sé/Sí an múinteoir cuí chun fiosrúcháin a dhéanamh ar eachtraí bhulaíochta agus dileáil leo ná an múinteoir ranga.

The relevant teacher for investigating and dealing with incidents of bullying is the class teacher.

❖ ‘Sí an príomhaidhm ná na fadhbanna a réiteach agus an gaol idir na páirtithe a réiteach, seachas milleán a chur ar éinne.

The primary aim is to resolve issues and restore the relationship between the parties as far as it is practicable, rather than to apportion blame.

❖ Caithfear gach tuairisc (fiú tuairiscí rúnda) a fhiosrú. Seo chun nós a chothú ina n-insíonn na leanaí a scéalta.

Each incident, even those that are confidential, is investigated. This is to encourage children to tell their stories.

❖ Foireann iomlán na scoile ar an eolas maidir le heachtraí a thuairisciú.

All members of staff are made aware of the need to report incidents.

❖ Comhoibriú tuismitheoirí/daltaí an-tábhachtach chun tacú le hobair na scoile chun bulaíocht a sheacaint.

The co-operation of parents and pupils is extremely important in trying to avoid bullying behaviour in the school.

❖ Tábhachtach go dtuigfidh gach duine an nós imeachta ón tús.

Important that all are aware of the procedures to be followed.

❖ Ba chóir do mhuinteoirí cur chuige socair, ar nós réiteach faidhbe, a leanúint i gcásanna bhulaíochta.

Investigating teachers should investigate cases in a calm and reasoned manner.

❖ Fiosrúcháin déanta taobh amuigh den seomra ranga níos fearr. Is féidir leanaí nach bhfuil páirteach a cheistiú chomh maith.

Investigations should be carried out outside the classroom. Children not directly involved may also be questioned.

❖ Lorg : Cad? Cathain? Cén ait? Cé? agus Cén fath? i slí socair chun sampla maith a bhunú i gcás réiteach faidhbe.

What? When? Where? Who? and Why? should be ascertained in a calm manner to set an example about seeking solutions to problems.

❖ Grúpa a cheistiú ina n-aonar ar dtús taobh amuigh den rang agus ansin le chéile.

A group could be questioned together having previously been questioned individually

❖ Tuairisc a lorg ó daltaí i Rang II agus ar aghaidh.

A written report may be sought from pupils of Rang II and upwards

❖ Más cás bulaíochta atá ann, ba chóir fios a chur ar tuismitheoirí go luath chun an scéal a mhíniú, laistigh de pholasaí na scoile.

If it is considered a case of bullying, then parents should be contacted as soon as possible to explain the situation, within the guidelines of the policy.

❖ I gcás bulaíochta ba chóir a dhéanamh sóiléir don duine á dhéanamh go bhfuil rialacha briste agus ba chóir féachaint air ó thaobh an duine eile de.

In the case of bullying, it should be made clear to the individual causing the bullying that rules have been broken and that they should try to see the incident from the other persons point of view.

❖ Má tá smachtbhannaí (sanctions) i gceist - is cás príobháideach é seo idir an scoil, an dalta agus a t(h)uismitheoirí.

Any sanctions taken will be a matter for the pupil, the parents, and the school

❖ Cruinnithe eile níos déanaí más gá.

Follow up meetings may be organised.

- Ar oibrigh sé/Did it work?

- Seans go lorgáitear dearcadh nó tuairimí an tuiste faoi céard a chabhródh. Plean gníomhach le inchur an an P.O.is dea-chleachtas/Parents may be asked for views or suggestions of what might help? Plan of action by Príomhoide's guidance and best practice.

- Monatóireacht ar an gcás thar tréimhse ama i dteannta leis an bpáiste is tuiste/Monitoring the situation over time and involving the pupil and parent/guardian in this.
- Comhairle a lorg ó NEPS, Banaltra scoile nó cuairteanna saineolaithe speisialta/Seeking advice of NEPS, School Nurse, or if appropriate school related professionals e.g. Visiting Teacher/Specialist.
- Seiceáil rialta le tuistí ar conas atá an páiste sa bhaile is ar scoil/Regular checks with Tuismitheoirí as to how the child is at home and what his/her opinion is of how things are at school.
- Breathnóireacht an mhúinteora ar an bpáiste is a c(h)aidreamh lena c(h)omhdhaltaí/Teacher observation of child and his/her interaction in groups. (Straiteisí féinsuaimhnis a mholadh/Relaxation techniques to be recommended)
- Straitéisí le comhoibriú an MOS agus na cláracha atá in úsáid leis na daltaí áirithe (m.sh.
